



Select "Create a New Account" to register.






Complete the required information and agree to the Terms of Service and Privacy Policy.








Once logged in, you will be directed to the homepage. From there, select the "Register for Certification" menu to apply for the Trusted Thailand logo.






For hotel operators, select one of the following types of accommodation:


- 1) Hotel with fewer than 50 rooms


You will then be directed to the establishment information form, which must be completed.





- If you are unable to provide the establishment's name, address, or highlight/tagline in Chinese, please fill in those fields in English.
- During the image upload process, you can upload logos and images for public relations use (images that will be displayed on the website) by clicking "Choose file." Once the image upload is complete, the uploaded image will appear below the upload bar. (Note: If the file size exceeds the specified limit, the image will not upload. You must reduce the file size before uploading. The maximum size per image is 5MB.)



After uploading, a preview of all images will be displayed.










After completing the information and uploading images, click "Save information and continue."




 If you are unable to complete all the information immediately, you can click "Save draft," allowing you to return to edit or fill in the establishment information later. 10

After saving the establishment information, you will be taken to the evaluation criteria page, where you can attach supporting documents in the form of images, document files (.PDF), or videos.






Once all required documents have been attached, you can save the draft, preview the information, and confirm the submission of the form.






After entering the establishment information and attaching required documents, you will be redirected to the establishment information page, where you can view the verification status on your profile page.






If the committee requires additional information, you will see the "Request for Additional Information" status in the top right corner of the registered establishment.



You can click on "Edit Form" to attach any additional documents as requested by the committee.




Once all information has been verified and approved, you will receive an "Approved" status in the top right corner of the registered establishment.




You can download the logo by clicking on the "Badge" menu.
